COMPLETE AND RETURN TO: FG42, INC.

The FG42 SA is a highly complex and sophisticated firearm system that requires knowledgeable and competent operators. Full and complete adherence to the operations manual and the following instructions, in addition to standard firearm safety practices, is an absolute necessity for safe and responsible use of the FG42 SA. This firearm is NOT meant for anyone other than individuals knowledgeable in the safe operation of magazine-fed systems and who have a thorough understanding of semi-automatic and automatic firearms. If you are not such an individual you pose a danger to yourself and those around you by using this system and we respectfully request that you return the firearm to FG42, Inc. immediately.

1. I certify that I have been provided a copy of and have thoroughly read the operations manual for the FG42 SA, a highly complex, experimental firearm and understand all of the risks and precautions therewith associated. I acknowledge that this firearm is a highly complex, sophisticated, and experimental device that merits my full adherence to operating procedures set forth in the FG42 SA operation manual (PIN: FG42 SA O.M. 07 REV 1) in addition to standard firearm safety practices. I also acknowledge that I am knowledgeable in the safe operation of magazine fed systems and have a thorough and competent understanding of semi-automatic and automatic firearms. I understand that this rifle is a faithful copy of an implement of war designed in 1942 Germany and though it is manufactured with modern materials, it does not incorporate any modern safeties or design modifications to make it a safer firearm to operate. Therefore, it is more dangerous than other modern firearms and should always be handled with this complete understanding.
2. I assume all risk of injury, death or damages to all others and myself resulting from use of the FG42 SA.
3. I shall hold harmless and indemnify FG42, Inc., its agents, officers, employees, representatives, consultants, subcontractors, vendors, suppliers, financiers, insurers, reinsurers, successors and assigns, and each and every one from any claims for injury, death or damages resulting from the use of the FG42 SA.
4. I shall not permit the use of this firearm by any individual who has not read and who is not able to fully comply with the requirements of the operations manual (PIN: FG42 SA O.M. 07 REV 1) and this Release wherein acknowledged by my signature on the date set forth below.
5. I shall take all precautions and extraordinary measures delineated, and those that not delineated in the operations manual (but which are standard firearm safety precautions) to ensure the safety of spectators, onlookers, and the general public and to ensure the preservation of property by taking the necessary safety precautions to prevent injury, death, or damage to all others and myself.
6. I understand that this waiver, assumption of risk, and agreement to hold harmless shall apply even if the injury, death or damages results from FG42 Inc., its agents, officers, employees, successors or assigns active or passive negligence.

I have read and understand this Release and shall comply with the terms and conditions set forth herein. I understand that by my signature I waive any and all rights afforded by my state which are contrary to the terms and conditions set forth herein. This Release shall remain effective until FG42 Inc. receives the necessary transfer release and validation is provided for the FG42 SA transfer. I have had ample time and opportunity to have this Release reviewed by counsel of my choosing if I so desire.

By purchasing any item from FG42, Inc., whether by mail or in person, the buyer warrants that he or she has checked and verified that he or she is in compliance with all federal, state and local laws, and is legally able to purchase any such items.

By signing below, the buyer also warrants subject to penalties provided by law, that in the case of any firearm or ammunition other than a shotgun or rifle, that the buyer is 21 years or more of age, or that, in the case of a shotgun or a rifle, that the buyer is 18 years or more of age; that the buyer is not prohibited by the provisions of Chapter 44 of Title 18, United States Code, from receiving a firearm or ammunition in inter-state or foreign commerce; and that the buyer's receipt of this firearm will not be in violation of any statute of the State in which buyer resides or published ordinance applicable to the locality in which buyer resides.
